# CALL FOR SUBMISSION OF EXPANDED ABSTRACTS

**1. GENERAL INFORMATION AND CONTEXTUALIZATION OF THE EVENT** The 1<sup>st</sup> **INTERNATIONAL CONGRESS OF LABOR LAW, TRADE UNION LAW AND SOCIAL RIGHTS** to be held between **November 29 to December 2, 2022**, in Manaus, at the Faculty of Law of the State University of Amazonas, will have, as its central theme, the challenges of democracy, labor and social rights) in the world in transition.

The event is a result of the collaborative research partnership within the scope of the DINTER- Interinstitutional Doctorate of the Federal University of Minas Gerais - UFMG and the Amazon State University - UEA. The event is organized by the research group Work on the Move - TREM/UFMG. This research group is also connected to professors of DINTER and are coordinated by Prof. Dra. Maria Rosaria Barbato (who is also the Coordinator of Dinter) and Prof. Dr. Alcian Pereira de Souza, her deputy. The Congress is a joint effort of professors and students of UFMG, UEA and Federal University of Amazonas - UFAM. The event will allow the consolidation of interinstitutional ties between the two institutions (UFMG and UEA), the partner institution (UFAM), and the supporting institutions.

The event proposes facilitating interdisciplinary debates on the law and its political, regulatory, social, economic, and normative dimensions. It also intends to provide an opportunity for exchanging experiences, knowledge, and views, from an interdisciplinary and transversal perspective that is both critical and reflective, about the thematic axis of labor law and social rights, including sociobiodiversity in the Amazonian context, also focusing on the improvement of this latter.

#### **2. TARGET AUDIENCE**

The target audience are undergraduate and graduate students of higher education institutions in law and related areas, professors, researchers, activists, specialists and others interested in the topics.

# **3. STANDARDS TO BE OBSERVED FOR THE SUBMISSION OF EXPANDED ABSTRACTS**

3.1. Abstracts should be unpublished.



3.2. Abstracts must comply with ABNT standards (we will not receive full articles at this stage).

3.2.1. Abstracts will be accepted (only in formats: .doc or .docx) in Portuguese, Italian, Spanish, French, and English, and if they are not shorter than 3 (three) pages and no longer than 4 (four) pages (A4 sheet, vertical position), including bibliography.

3.2.2. The abstract must contain: title, objectives, methodologies, research development, conclusions, keywords and references.

3.2.3. Three to five keywords of the expanded abstract shall be included.

3.2.4. Formatting issues: Times New Roman; capitalized titles (in the original language and English) in font 14, centralized, bold; the body of the text is in 12, justified alignment; without separation of syllables; spacing 1.5 between lines; paragraph 1.5 cm; top and left margins with 3 (three) cm and bottom and right with 2 (two) cm; and there should be no space between paragraphs.

3.2.5. Citations (NBR 10520/2002) and references (NBR 6023/2018) must comply with ABNT rules.

3.2.6. The system for calling references of direct or indirect citations should be authordate (ABNT NBR 10520/2002), with footnotes being only explanatory (NBR 6022/2003).

3.2.7. After submission of the abstract, replacement, correction, alteration of the content will not be permitted.

3.2.8. Abstracts submitted will undergo editorial analysis. Abstracts that fail to meet these abovementioned standards will be rejected.

3.2.9. Authors, when submitting their abstracts and posters, automatically assign and transfer irrevocably and free of charge all copyrights related to the work to the I<sup>st</sup> International Congress of Labor Law, Trade Union Law and Social Rights, notably the rights of publication, reproduction, editing, adaptation, translation, distribution, printing, marketing, and others, provided for in art. 29 of Law 9.610/98, for editorial, commercial, educational, technical and cultural purposes, not consisting of any remuneration to them. The I International Congress of Labor Law, Trade Union Law and Social Rights is authorized to promote the editions, total or partial, that it deems opportune and in any number of copies, as well as the distribution and national or foreign circulation in any medium, of storage. , broadcasting and distribution of the work. The present assignment authorizes the I International Congress of Labor Law, Contracting or authorizing its edition to third parties. It also allows, definitively and irrevocably, to assign these same rights that it now holds.

# 4. AUTHORS

4.1. Papers can be co-authored by a maximum of 3 (three) authors.

4.2. The works of undergraduates, graduates and specialists will only be considered if written in co-authorship with at least one master/master's degree **and/or** phD/doctoral student.

4.3. The author submitting the abstract is responsible for including the name of the other author(s) and for defining the order in which the names are presented.

4.4. After submission of the abstract, inclusions of authors and changes in the order of names will not be accepted.

# **5. SUBMISSION OF EXPANDED ABSTRACTS**



5.1. Abstracts will be received until **September 23, 2022**, precisely until **11:59 pm**, Brasília time.

5.2. Each author may submit a maximum of 2 (two) abstracts, provided that they belong to different Working Groups, according to Annex I. Different abstracts must be sent to the indicated (different) email addresses. If more than two abstracts are received per author, only the first 2 submissions in chronological order will be considered. If rejection happens for not complying with this rule, it could raise the liability of the author who submitted more abstracts than allowed towards his or her co-authors.

5.3. The e-mail sent for the submission of abstracts must also contain the address of the co-authors (including the mentoring co-author) all of whom must reply all recipients their consentment by email within 24 hours.

5.4. Each email sent must contain 2 (two) files. One with an anonymous abstract, the other with the abstract containing the complete indication of the authors. Only in the identified file, should the name of the author(s) be included, followed by the title and institutional affiliation with a spacing of 1.5, left-aligned

5.5. The expansive abstract shall indicate the Working Group. The Working Groups (WGs) are as follows: (Annex I)

- 2. Gender, race, sex, ethnicity, people with disability and other vulnerabilities: the interfaces of the debate on inclusive practices and human rights.

- 4. The fight against contemporary slave labor in the context of contemporary crises and transitions.

- 6. Labor jurisdiction: reconfiguration of perimeters, access restritions, emptying, and impact/ implications of the generational transition of bureaucratic frameworks.

- 8. Attacks on social rights, regulatory variations and comparative law.
- 9. Challenges of social movements and struggles for/against the law: conflicts, resistance and insurgencies.

- 11. Human rights of workers between affirmation, violation and transitional justice: critical constitutional perspectives, international law and the experiences of comparative law.
- 12. Constitutionalization of social rights and expansion of protection systems in the domestic and the global orders.
- 13. Institutional reconfiguration and redesign to discuss public policies for the realization of the right to health, education and other social rights in the contemporary scenario.
- 14. Labor citizenship and fundamental rights: epistemological, institutional and social impasses.
- 15. New migrations and profiles of migrants: agendas of critical and jusphilosophical theory, offensive public policies, constitutional and international law.



- 16. Democratic erosion and social setback in Latin America: political transitions and their derivations.
- 17. Transnational companies, social and corporate environmental responsibility: perspectives of constitutional, international and comparative law.
- 18. Strategies for strengthening trade unions and collective actions in the world in transition.
- 19. Labour democracy and social rights in their cultural, artistic, and literary expressions
- 20. Ecology, climate relations, socio-environmental law and sustainability: from local to global, departing from the Amazon region.
- 21. Right to difference and self-determination of traditional peoples: constitutional and international protection in the Amazonian context.
- 22. Predatory capitalism and social issues in the Amazonian region: challenges for public policies and social rights.
- 23. Special GT: 4 chiacchiere e un caffé: uno sguardo alle migrazioni italiane in Amazzonia e in Brasile (A chat and a coffee: a look at the Italian migrations in the Amazonas and in Brazil)

5.6. Each abstract must be sent to the <u>congressodireitossociais@gmail.com</u>, indicating in the subject of the email "ABSTRACT FOR THE WG (WG NUMBER AND NAME)". In the body of the e-mail, the following must be informed: 1) title of the work in the original language; 2) name of the WS; 3) full name of the author(s); 4) institution/city; 5) e-mail and phone number of the contact person.

5.7. After submission of the abstract, replacement, correction, alteration of the content or of any nature shall not be allowed.

5.8. Abstracts submitted will undergo editorial analysis. Those who do not comply with the rules of this notice will not be accepted for publication.

5.9. If there is interest in the submission of works in formats other than described in the present call (such as poems, artistic performances, short, etc.), an e-mail is required to be sent to the Organizing Committee **congressodireitossociais@gmail.com** informing them about the proposal, specifying the format and indication of the relevant WG.

#### 6. EVALUATION

6.1. All submitted abstracts will be evaluated in two stages:

**Step I** - Reviewers will evaluate whether the abstracts comply with the requirements of this call. Failure to do so will result in a rejection.

**Step II** – The abstracts approved by the reviewers will be forwarded to the evaluation committee, which will judge the merits of the work according to the following criteria:

a) Timeliness, originality and relevance of the theme.

b) Relevance of the title and quality of the abstract.

c) Theoretical consistency.

d) Clarity, relevance and feasibility of the objectives.

e) Methodology (adequacy and quality).

f) Analysis of research data and results.

g) Theoretical and methodological articulation of interpretation.

h) Conclusions: foundation, coherence and coverage.

6.2. The list of approved abstracts will be published on https:// https://pos.uea.edu.br/direitoambiental https://pos.direito.ufmg.br/ until and October 12, 2022.



6.3. If a WG has a large number of approved abstracts, the organizing committee may subdivide these groups; similarly, presentations of research lines with low demand can be gathered into a single Working Group.

6.4. An appeal against the final decision of the evaluation is not available at any stage of the process.

# 7. PRESENTATION IN THE WORKING GROUP (WG)

7.1. Each WG will have two to three coordinators, determined by the organizing committee, who will determine the order of the presentation and moderate the discussion. 7.2. Each participant will have 10 (ten) minutes to present the theme. After this time, 5 (five) minutes will be given for receiving guidance, observations and comments from the WG coordinators and other WG participants.

7.3. No multimedia equipment (data show, microcomputers, etc.) will be available.

7.4. An oral presentation is a requirement for granting the certificate.

7.5. Only the registered authors of the Congress are allowed to make the oral presentation of the approved abstract.

7.6. The presentation shall be certified only to the author(s) who participate in the WG session, without prejudice to the publication of the abstract with reference to all co-authors.

# 8. PUBLICATION IN THE ANALS OF THE EVENT

8.1. Only abstracts presented at the event will be published in the Anals.

8.2. The event's Anals will be published in electronic and/or printed format.

8.3. The author will not be allowed to review, alter or replace abstracts after submission for publication in the Anals.

8.4. The content of the published works will be the sole responsibility of the author(s), who must strictly comply with the current rules of copyright and ethics of scientific research. The author(s) are required to keep the organizing committee and the Universities involved in the case of any act of violation of copyright, plagiarism and/or indemnification actions brought by third parties.

8.5. Authors, when submitting their abstracts, assign and transfer automatically, irrevocably and free of charge, all copyrights related to the work to the I International Congress of Labor Law, Trade Union Law and Social Rights, notably the rights of publication, reproduction, editing, adaptation , translation, distribution, printing, marketing, and others, provided for in art. 29 of Law 9.610/98, for editorial, commercial, educational, technical and cultural purposes, not consisting of any remuneration to them. The 1<sup>st</sup> International Congress of Labor Law, Trade Union Law and Social Rights is authorized to promote the editions, total or partial, that it deems opportune and in any number of copies, as well as the distribution of the work. The present assignment authorizes the I International Congress of Labor Law, Union Law and Social Rights, to transmit the rights of economic use of the work, contracting or authorizing its edition to third parties. It also allows, definitively and irrevocably, to assign these same rights that it now holds.

#### 9. ANALYSES AND PUBLICATION OF THE FULL PAPERS

9.1. Full paper versions of the presentations at one of the Working Groups of the 1<sup>st</sup> **International Congress on Labor Law, Trade Union Law and Social Rights**, will be accepted for evaluation and possible publication (in an edited book)



Attention: Only complete works of approved abstracts, whose authors have registered and orally presented their work in the Working Groups will be accepted. The registration and presentation of the abstract made by at least one of the co-authors will be considered valid for the end of the final publication.

In the body of the e-mail, the following should be informed: 1) title of the work; 2) WG in which it was presented; 3) full name of the author(s);4) institution/city of origin; 5) email and contact phone; 6) term of assignment of rights completed and signed (as model of Annex II).

9.3. The submission of the finalized work does not guarantee the publication in an edited book. The finalized papers will be evaluated by the multidisciplinary scientific committee composed exclusively of researchers having PhD or doing doctoral studies. This committee will **publish the final result until February 15, 2023**. The book will be edited and published in print and/or electronic book with ISBN and DOI.

9.4. The finalized and submitted work must be unpublished and may not have been published previously.

9.5. Formatting the finalized work: Times New Roman, font 14; capitalized title in the language in which the paper is written and in English, centered, bold, the subtitle, if there is any, should be included after the title, separated by a colon, written in lowercase letters; the body of the text: font size 12; justified alignment; without separation of syllables, spacing 1.5 between lines; paragraph of 1.5 cm; upper and left margins with 3 (three) cm and lower and right with 2 (two) cm; and there should be no space between paragraphs. The name of the author(s) should be included below the title with a spacing of 1.5, aligned to the left. Below the full name, the title and institutional affiliation must be included. The abstract in the language in which the paper is written and in English, with a maximum of 250 words each, should be included below the authorship identification, without paragraph indentation, with simple spacing, containing 3 (three) to 5 (five) keywords.

9.6. Bibliographic references should be cited in author/date system (NBR 10520/2002), with footnotes being only explanatory (NBR 6022/2003). Complete bibliographic references should be presented alphabetically at the end of the text, according to ABNT standards (NBR-6023/2018).

9.7. The complete work shall contain a maximum of 45,000 characters (counting spaces), which corresponds to approximately 15 (fifteen) pages, including the abstract in the language in which the paper is written and the abstract in English, the keywords, the body of the text, and the bibliographic references.

9.8. The non-observance of any of the rules set forth herein will imply the non-acceptance of the work for publication.

9.9. The non-observance of any of the rules set forth herein will imply the non-acceptance of the work for publication.

# **10. DECLARATIONS, PUBLICACTIONS AND CERTIFICATES**

10.1. All declarations and certificates relating to the **1st International Congress of Labor Law, Trade Union Law and Social Rights** will be issued by the organizing committee and will be sent to the e-mails registered by the author(s) at the **congressodireitossociais@gmail.com.** 

10.2. The authors, when submitting their abstracts automatically, irrevocably, and freely reliquish any correspondent copyright to the 1<sup>st</sup> International Congress of Labor Law, Trade Union, Law and Social Rights without any financial compensation.



10.3. The 1<sup>st</sup> International Congress on Labor Law, Trade Union Law and Social **Rights** may decide to publish abstracts and finalized articles with reference to the respective author(s) and event, either in digital or printed format, in the Anals s of the event or in other forms of publications.

10.4. Only the author who submitted his work and signed the attendance list in his/her respective WG will be issued his/her certificate of attendance.

10.5. The publication of the abstract is conditional on the presentation of the work in the respective WG by (at least one of) the author(s).

10.6. All registered participants that attended a minimum of 75% of the presentations are entitled to the certificate of participation.

10.7. It is the responsibility of all registered participants to record their attendance on a daily basis at the locations indicated for this purpose.

10.8. For the purpose of calculating the frequency of attendance, the daily events should be considered, as they appear in the official schedule.

# **11. THE REGISTRATIONS AT THE EVENT**

11.1. The registration fee for the presentation of abstracts and participation as an audience is R\$ 70.00 (seventy reais) if paid between October 13 and November 1, 2022 and R\$ 100.00 (one hundred reais), if it is paid between November 2 and November 10, 2022.

11.2. For undergraduates, the registration fee for the presentation of the representations and participation as an audience is R\$ 20.00 (twenty reais) if paid between October 13 until November 1, 2022 and R\$ 30.00 (thirty reais) if paid between November 2 and November 10, 2022.

11.3. Regardless of the number of abstracts approved, participants pay a single fee.

11.4. The organizing committee will not refund payments or transfer them to third parties under any circumstances.

11.5. Registered participants may attend the event as an audience. In this case, they will receive a certificate of participation, provided that they have attended at least 75% of the sessions of the event.

11.6. The organizing committee will inform about the modalities of delivery of certificates and declarations.

11.7. The registration fee must be paid exclusively through access to the Sympla events platform. The payment access link will be made available by the organizing committee from October 12, 2022.

# **12. FINAL PROVISIONS**

12.1. The non-observance of the provisions contained in this Call during or after the event, will result in the refusal of the abstract and the finalized paper. This decision is made by the organizing committee. In the case of refusal, no refund is made, and no certificate is issued.

12.2. The Organizing Committee reserves the right to resolve, at its discretion, any issues relating to the question of interpretation or application of this call, its alleged errors, redundancies or omissions.

12.3. It is the full responsibility of the author(s) to respect the rules stipulated in this call, as well as the monitoring of the notifications of the organizing committee about the details of the event. These notifications will be sent by e-mail and made available on the websites.
